

Cookie Policy

Our use of cookies

Welcome to http://www.activityalliance.org.uk (Site), which is owned and operated by English Federation of Disability Sport (trading as Activity Alliance).

Here you will find information on what cookies may be set when you visit the Site and how to reject or delete those cookies.

By continuing to use this site you are agreeing to our use of cookies in the manner described in this policy.

What are cookies?

A cookie is a small data file that is placed on your computer or other device to allow a website to recognise you as a user when you return to the website using the same computer and web browser, either for the duration of your visit (using a 'session cookie') or for repeat visits (a 'persistent cookie').

Other similar files work in the same way and we use the word 'cookie' in this policy to refer to all files that collect information in this way.

Please note that some cookies used on our Site may be set by third parties, e.g. google analytics over which we have no control. The types of cookies we use are detailed below:

Session Cookie (efds session)

This is fundamental to the working of the website and allows us to retain the session as a user moves from one page to another, ie. login functionality, passing error messages or inprogress form IDs. This does not contain any user identifiable information.

Consent Cookie (activity alliance cookies consent)

Cookies are used on our website to user preferences. This does not contain any user identifiable information.

Google Analytics (_gid, _ga, _gat)

Cookies are used to track use of the site in Google Analytics.

Google Maps

Google may set a cookie to allow the maps to be displayed.

Google ReCaptcha

Cookies are set by the ReCaptcha feature on contact forms to allow us block spam form submissions.

How to control and delete cookies

When you accessed the Site, you were presented with a message that notified you of our use of cookies. We had to use a cookie to present you with that notice (you can see details of this cookie under 'Cookie Banner' in the table below). If you continue to use the Site, more cookies and other tracking technologies will be placed on your computer as described in this Cookie Policy in order to enhance your user experience whilst on the Site (as relevant).

You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies or in the Cookie Banner when you visit our Site. However, if you refuse all cookies you may be unable to access certain parts of the Site. Also, if you refuse essential cookies then certain parts of our Sites may not operate properly or at all. Unless you have adjusted your browser settings so that it will refuse cookies or you refuse cookies in the pop-up box when you visit our Site, our system will issue cookies when you access the Site.

These cookies are needed for our website to function, provide payment gateway security and other essentials.

Purpose	Examples of purposes for which a cookie may be used: This cookie is essential for the Site to: remember who you are currently signed in as; store preferences about your visit, such as the country you're visiting from; display notifications confirming actions you perform on the Site, such as a confirmation message when you've signed in; and store your basket, so you can place an order.
Expires	This cookie expires at the end of your browsing session.

Email Tracking

We use Campaign Monitor and Vuelio to set pixels on our newsletters and weekly media alerts. This allows us to identify when you have opened our newsletters or media alerts. We use this information to determine which parts of our emails are of most interest to you.

You can delete the pixel by deleting the email. If you do not wish to download the pixel to your computer or other device, you can ensure this by selecting to receive emails from us in plain text rather than HTML.

Alternatively, you can unsubscribe from our newsletters or media alerts by clicking the unsubscribe button at the bottom of those emails.
