Entry deadline for athletes requesting classification:

**Sunday 24<sup>th</sup> April – 12pm: £14 per event**

All entries must be made via the online entry system. Closing date for entries is 12pm 24<sup>th</sup> April 2024

Entry deadline for those not requiring Classification.

**Sunday 10<sup>th</sup> May – 12pm £14 per event**

All entries must be made via the online entry system. Closing date for entries is 12pm 10<sup>th</sup> May 2024

**Additional/Late Entries after the deadline: £29 per event**

Additional Swims, for swimmers who have already entered before 12pm on 10<sup>th</sup> May 2024 and late entries will be accepted after the closing date, up to 5<sup>th</sup> June 2024 at 12pm this will be at a cost of £29 per event.

## Para-Swimming Conditions

### Championship Information

- 3 age groups will operate.
- Group A – Aged between 10-13 on the 31<sup>st</sup> December 2024
- Group B – Aged between 14-16 on the 31<sup>st</sup> December 2024
- Group C – Aged between 17-18 on the 31<sup>st</sup> December 2024
- International Swimmers are welcome to enter but must have a recognised Classification that is on the World Para Swimming or Affiliated Nation Classification Database at the time of entry.

**Location:** The Alan Higgins Centre, Coventry

- 8 lane 25m pool, there will be a separate 8 lane pool 20m pool for swim up/down

**Date:** 8-9 June 2024

### Eligibility

- All GB competitors must be registered as members of a swimming club affiliated to Swim England, Scottish Swimming or Swim Wales at the time of entry.
- **Must hold a category 2 membership or equivalent**
- All competitors must be at least 10 years of age on the 31<sup>st</sup> December 2024
- Open/Male and Female races will be swam separately.
- International swimmers are invited to enter

#### **Functional (S1-S10, SB1-SB9, SM1-SM10)**

All competitors must have the following authorised classification at the time of entry:

- British Swimming which is held on the British Swimming Classification Database
- World Para Swimming which is held on the WPS Classification Database
- Home Nation Classification which is Affiliated to WPS.

#### **Visual (S11-S13, SB11-SB13, SM11-SM13)**

All competitors must have the following authorised classification at the time of entry:

- British Swimming which is held on the British Swimming Classification Database
- World Para Swimming which is held on the WPS Classification Database
- Home Nation Classification which is Affiliated to WPS.

#### **Intellectual (S14, SB14, SM14)**

All competitors must have the following authorised classification at the time of entry:

- Authorised SportExcel UK or VIRTUS Registration which is held on the British Swimming Classification
- Authorised VIRTUS Registration, which is held on the World Para Swimming or Affiliated Nations Classification Database.

#### **Deaf (S15, SB15, SM15)**

- All competitors must have an authorised UK Deaf Sport or GB Deaf Swim Certificate or CISS/ICSD classification, which is held on the UK Deaf Sport or ICSD classification database at the time of entry.

## Rules

- The event will be held under Activity Alliance Swimming Rules. Activity Alliance have adopted WPS Swimming rules and regulations with some additions.
- The Competition shall be held under World Para Swimming Judicial Rules and Regulations (excepting Protest fees) together with any changes and or additional conditions. Where World Para Swimming Rules do not provide (e.g. Health & Safety Regulations or Safeguarding Guidelines) the requirements of Swim England shall apply to events held in England.

## Protests

- WPS Rule 10.12 governs the management of Technical Protests. Whilst for this event the WPS procedure contained within will be followed, the fees referred to in rules 10.12.2 d and 10.12.6.2 shall in both cases be replaced by the protest fee and appeal fee each being nil.

## Entry information

1. British Swimmers go to the [Online Entry Page](#).
2. Enter your membership number or surname
3. Providing you have qualified a list of events you have qualified in will appear ticked
4. Untick any events which you do not wish to enter.
5. Payment is via debit or credit card, please follow the PayPal payment instructions. You do not need a PayPal account to do this. Your entry will not be complete until you receive a confirmation of payment email from PayPal.

- **All entries will be made online, no other entries will be accepted**
- Swimmers who wish to be considered for **national classification** need to enter online by **26<sup>th</sup> April 2024** to be eligible to be called for classification. National classifications will take place on **Thursday 6<sup>th</sup> and Friday 7<sup>th</sup> June 2024** prior to the start of the championships Improved entry times will not be accepted after the closing date
- Improved entry times will not be accepted after the closing date
- Qualifying times must have been achieved, these may be achieved in either a long course or a short course pool. Times must be achieved at licensed meets, times from time trials will not be accepted.
- No refunds will be given if withdrawal occurs.
- The event will be held under Activity Alliance Swimming Rules. Activity Alliance have adopted WPS Swimming rules and regulations with some additions.
- The Competition shall be held under World Para Swimming Judicial Rules and Regulations (excepting Protest fees) together with any changes and or additional conditions. Where World Para Swimming Rules do not provide (e.g. Health & Safety Regulations or Safeguarding Guidelines) the requirements of Swim England shall apply to events held in England.

## Protests

WPS Rule 10.12 governs the management of Technical Protests. Whilst for this event the WPS procedure contained within will be followed, the fees referred to in rules 10.12.2 d and 10.12.6.2 shall in both cases be replaced by the protest fee and appeal fee each being nil.

## Withdrawals

- Withdrawals for the first day's competition must be made by 12:00 on the day before competition starts.
- Withdrawals for subsequent sessions must be made by the end of the last session before the proceeding session of competition.
- All Withdrawals should be notified to the Recorders.
- For Heats (see below), for Finals no later than 15mins after the conclusion of the relevant Heat Session.
- Withdrawals for Day 1 Heats should be made by 17:00hrs on the day prior to the Heats
- Withdrawals for Day 2 should be made no later than the End of Day 1 Finals Session

## Medals / Finals

- We will host open/male and female finals in the following events based on the criteria below. Swimmers will make finals based on the top 8 highest British Para-Swimming scores achieved in heat swims. If there are swimmers with the same amount of points a swim off will happen after the heats session. If after the swim off there is still a tie on points preference will be given to the swimmer where this is the swimmers Paralympic class event. If there is a still a tie it will go on entry times equated into British Para-Swimming points. All other events will be swam as Heat Declared Winners (HDW).
- **Medals will be awarded to 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> based on the highest points scored in the final or HDW.** Group A will be awarded medals in their age group by British Para-Swimming points even if a swimmer makes a final and does not finish in a medal position.
- **There will be a maximum of 2 overseas swimmers permitted to enter to finals the top 2 highest scoring swimmers will progress to finals.** If there are enough overseas swimmers who would qualify for finals a B final will be explored and all swimmers will be informed at the end of session as to who has made finals.
- Finals will be swam at the end of each session. An appropriate break will be implemented for athletes to recover

S1 – S15 100m Freestyle	Minimum of 20 swimmers enter event
SM5 – SM15 200m Individual Medley	Minimum of 10 swimmers enter event
S1 – S15 50m Freestyle	Minimum of 20 swimmers enter event
SB4 – SB15 100m Breaststroke	Minimum of 10 swimmers enter event
S6 – S15 100m Backstroke	Minimum of 10 swimmers enter event
S8 – S15 100m Butterfly	Minimum of 10 swimmers enter event

## Relays

- We are introducing relays and would like to provide all swimmers with an opportunity to participate. The format will be 4 x 50m Freestyle. To be considered for the relay you need to enter either the 50m or 100m Freestyle event. Swimmers will be allocated into a relay team and swimmers teams will be published online.
- Relays will be swam at the end of session 3.
- Swimmers can withdraw from relays and need to inform registration desk

## Athletes Accreditation

- Passes can be collected from The Alan Higgins Centre, Coventry from 4pm-6pm on Friday 7<sup>th</sup> June 2024

## Poolside passes

- All poolside coaches and support staff must have accreditation.
- Coach/staff accreditation costs £13 per person
- All coaches, team staff and personal care attendants must conform to the Activity Alliance Safeguarding Policy and must complete a 'Self Declaration Form', this will be emailed out after receipt of payment

- Please note that only coaches and authorised support staff can apply for accreditations.
- Only athletes classified with Code of Exceptions A, Y, or T are permitted to have Support Staff on the Field of Play".

## N.B Reminder to support staff

- **Support staff shall not coach the competitor while assisting or tapping. If such coaching occurs, the competitor shall be disqualified.**
- **For physical classified swimmers, support staff are in place solely to assist the swimmer on entry, exit and at the start and shall not verbally communicate with the swimmer.**

## Doping Control

When entering the competition, the system will check to see if you have filled in a British swimming drug acceptance form. If you have not filled one in previously the form will be need to be filled in and return. This is automatically populated and produced, in the application process. This form needs to be completed and returned before you can enter the competition. If the Athlete is under 18 then a parent or guardian needs to complete the form. - It is the responsibility of each athlete to comply with the Anti-Doping Rules of British Swimming while at this event. The Anti-Doping Rules of British Swimming can be viewed at [www.britishswimming.org](http://www.britishswimming.org)
- As a condition of entry competitors agree if selected for testing to submit to Doping Control under the jurisdiction of British Swimming.
- Results management for any Anti-Doping Rule Violation will remain the responsibility of the applicable National Federation.
- Athletes on the World Class Pathway are responsible for ensuring that they have a valid Therapeutic Use Exemption (TUE) to use any substance that is considered prohibited under the current World Anti-Doping Code Prohibited List
- Other British Swimming or home nations athletes will need to apply for a retroactive TUE following doping control to use any substance that is considered prohibited under the current World Anti-Doping Code Prohibited List
- International athletes attending will be required to conform to their own Governing Body procedures

## Competitors Code of Conduct

We have a responsibility to promote high standards of behaviour in the sport. Competitors and staff will at all times be expected to adhere to the following minimum standard of behaviour and conduct.

- Respect the spirit of fair play
- Take responsibility for my own behaviour
- Respect the rights and dignity of others and never be involved in discrimination of any kind
- Never use inappropriate language or gestures
- Always behave in a considerate way towards fellow participants, officials, classifiers, event organisers and venue/hotel staff
- Protect others from verbal or physical abuse and threatening and intimidating behaviour
- Never take part under the influence of alcohol or drugs
- Not possess any prohibited substances or performance enhancing drugs as set out within the national policies adopted by UK Sport and British Swimming
